RESOLUTION NO. 2017.10

JURISDICTIONAL TRANSFERS  
COUNTY TRUNK HIGHWAY "CC", CTH "K", CTH "N", STH "83"

WHEREAS, the Town of Hartford is authorized to make additions and deletions to the Roadway System with the approval or consent of the Department of Transportation and the governing bodies in which the proposed change is located; and

WHEREAS, in consideration of the transfer of additional roadway of approximately 0.2 miles of Pioneer Road from Mayfield Road to Richfield Parkway from the Town of Polk Highway System to the State Trunk Highway System; and

WHEREAS, the Town Board of the Town of Polk will by resolution consent to the deletion of County Trunk Highway "CC" from CTH "E" southerly 1 mile to the Southwest corner of the Town of Polk from the County system to the Town of Hartford System, subject to negotiation and execution of the documents and agreements of transfer; and

WHEREAS, the Town Board of the Town of Polk will by resolution consent to the deletion of Pioneer Road from STH 175 to Mayfield Road from the Village of Richfield system to the State Trunk Highway system, subject to negotiation and execution of the documents and agreements of transfer; and

WHEREAS, the Town Board of the Town of Polk will by resolution consent to the deletion of County Trunk Highway "FD" from USH 45 to Interstate Highway 41 from the County Trunk Highway system to the State Trunk Highway system, subject to negotiation and execution of the documents and agreements of transfer; and

WHEREAS, the final form of the agreement between Washington County and the Town of Hartford will be negotiated and executed as part of the transfer; and

WHEREAS, the agreement will address, among other important points, the transferring of corresponding rights-of-way and interests by a detailed description and the designation of the transferred highways;

NOW, THEREFORE, BE IT RESOLVED by the Town of Polk Board that the jurisdictional transfers of that portion of County Trunk Highway "CC" from Washington County to the Town of Hartford and that portion of County Trunk Highway "FD" from Washington County to the State of Wisconsin, and that portion of Pioneer Road from the Village of Richfield to the State of Wisconsin described herein is authorized.

BE IT FURTHER RESOLVED that, subject to approval of the Washington County Board of Supervisors and the Department of Transportation, the Town of Polk Board hereby approves the transfer of roadway from the Town System that portion of Pioneer Road to the State of Wisconsin Highway System as described in the jurisdictional transfer agreement with the Town of Polk.


BE IT FURTHER RESOLVED that this transfer be effective on the date provided in the Jurisdictional Transfer Agreement.




